
When making a Vehicle Licence Application

Sandwell Council requires that all licensed vehicles must be M1 type approval.

How to provide proof of M1 status for your vehicle?

Step One: Your vehicles log book shows M1 status. Your log book is also known as the Vehicles [V5] Registration document. An example is shown below.



Step Two:

Does your log book (V5) show the vehicle category as M1?

Your vehicles M1 Status is on page 2 of your V5 log book under Vehicle Details D4 'Wheelplan'.

Your M1 status for your vehicle is located under 2-AXLE-RIGID BODY as shown above.

If your log book (V5) shows M1 Status, continue with your application.

If your log book (V5) does NOT show M1 Status you will need to get a Single Vehicle Approval or Individual Vehicle Approval Certificate [example of form required is shown in Step Three] from Driver and Vehicle Standards Agency at <u>Approval.Technical@DVSA.gov.uk</u>.

Step Three:

Do you have a Single Vehicle Approval or an Individual Vehicle Approval Certificate?



If Yes continue with your application and provide the SVA or IVA certificate [example shown left] which must specify that your vehicle is M1 status, along with a copy of your V5 to the Taxi Licensing Team with your application.

If you do NOT have a Single Vehicle Approval or an Individual Vehicle Approval Certificate [example of certificate shown left] contact the Driver and Vehicle Standards Agency at <u>http://Approval.Technical@DVSA.gov.uk/</u>
