

**SANDWELL METROPOLITAN BOROUGH COUNCIL**  
**ROAD TRAFFIC REGULATION ACT 1984**

**THE BOROUGH COUNCIL OF SANDWELL (VAISAKHI IN THE PARK – VICTORIA PARK SMETHWICK) (TEMPORARY ROAD CLOSURES AND NO WAITING AT ANY TIME RESTICTION) ORDER 2024**

In order to facilitate road closures associated with 2024's Vaisakhi in the Park event the Borough Council of Sandwell in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984, and after informing all other enabling bodies on 9<sup>th</sup> May 2024 intends to make the following Order:

1. Except as provided in Clauses 3 and 4 below, on 12<sup>th</sup> May 2024, between 10.00hrs and 20.00hrs, no person shall cause any motor vehicle to proceed along those roads in Smethwick listed in Schedule 1 of this Order.
2. Except as provided in Clauses 3 and 4 below, on 12<sup>th</sup> May 2024, between 10.00hrs and 20.00hrs, no person shall cause any motor vehicle to wait in those roads in Smethwick listed in Schedule 2 of this Order.
3. The provisions of Clauses 1 and 2 shall not apply to any motor vehicle which is being used:
  - (a) by the Police, Fire Brigade or Ambulance Service.
  - (b) by the Local Authority or Statutory Undertaker in pursuance of their statutory duties or powers.
  - (c) by a vehicle displaying in the relevant position a disabled person's badge.
  - (d) by a vehicle which requires access to premises on or adjacent to that road, which is only accessible from that road and which the driver has been issued with a residents' pass.
  - (e) by a vehicle being used for the operation of a local service.
4. The provisions of Clauses 1 and 2 shall not apply to anything done with the permission of or at the direction of a Constable in uniform.
5. No diversion routes will be signed.
6. In this Order "motor vehicle" has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984.
7. This Order may be cited as The Borough Council of Sandwell (Vaisakhi in the Park – Victoria Park Smethwick) (Temporary Road Closures and No Waiting at any time restriction) Order 2024

## **SCHEDULE 1**

**No person shall cause any motor vehicle to proceed along  
the following roads in Smethwick  
(10.00hrs – 20.00hrs)**

Park Retreat – in its entirety.

Suffrage Street – western arm in its entirety from its junction with Corbett Street.

Victoria Avenue – in its entirety

## **SCHEDULE 2**

**No person shall cause any motor vehicle to wait or load on  
the following roads in Smethwick  
(10.00hrs – 20.00hrs)**

High Street – eastern side from its junction with Victoria Avenue to its junction with Corbett Street
