Out of Borough ²

Charges for out of borough burials and burial/scattering of cremated remains incur an additional charge of 30% on both the burial fee and Exclusive Rights of Burial:

Definition of out of borough:

- The person to be buried is not a resident of the Borough of Sandwell at the time of death unless the grave was purchased before 1 April 1990.
- In the case of a stillborn child when neither parent is a resident at the time of stillbirth.

Out of hours ³

Charges for burials booked for out of hours will incur an additional charge of 30 % on the burial fee and chapel fee, if required:

Definition of out of hours:

If the burial is booked for a:

- Saturday, Sunday or Bank Holiday
- **or** 3:15pm or later from October to March (Monday to Friday)
- or 4pm or later from April to September (Monday to Friday)
