THE BOROUGH COUNCIL OF SANDWELL (WOMEN CHAINMAKERS PARADE) (TEMPORARY CLOSURE OF LOWER HIGH STREET, WHITEHALL ROAD, HIGH STREET, CORNGREAVES ROAD, PENNANT ROAD, PRINCE STREET, FIVE WAYS JUNCTION CRADLEY HEATH) ORDER 2025

In order to facilitate road closures associated with a procession being held in association with 2025's Women Chainmakers Festival the Borough Council of Sandwell in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 and after informing all other enabling bodies intends on 26th June 2025 to make the following Order: -

 Except as provided in Clauses 4 and 5 below on 28th June 2025 between 15.00hrs and 17.30hrs no person shall cause any motor vehicle to proceed along or to wait in the following roads in Cradley Heath

Lower High Street

Whitehall Road

Five Ways Junction - (closing access & egress by motor vehicles to High Street, Graingers Lane, Cradley Road, Lower High Street, St Anne's Road off Five Ways Junction)

St Anne's Road (Five Ways Junction to Foxoak Street)

High Street

Corngreaves Road (High Street - Pennant Road)

Newtown Lane (Foxoak Street to High Street)

Prince Street (High Street to Pennant Road)

- 2. The one-way operation of Whitehall Road will be temporarily revoked between 15.00hrs and 17.30hrs on 28th June 2025 when roads are closed and the parade in processing only with access / egress off Compton Road only.
- 3. The provisions of Clauses 1 and 2 shall not apply to any motor vehicle which is being used by the Police, Ambulance Service or Fire Service in pursuance of their statutory powers and duties or any motor vehicle which is being used by a statutory undertaker in an emergency such as the loss of supplies of gas, electricity or water in the area which necessitates the bringing of vehicles into the roads specified in Schedule 1 and 2 of this Order.

- 4. The provisions of Clauses 1 and 2 shall not apply to anything done with the permission of or at the direction of a Constable in uniform.
- 5. In this Order "motor vehicle" has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984
- 6. This order may be cited as the borough council of Sandwell (Women Chainmakers festival and parade) (temporary closure of Lower High Street, Whitehall Road, High Street, Corngreaves Road, Pennant Road, Prince Street, Five Ways junction, Cradley Heath) Order 2024
