Tipton Green	Cllr Jeffcoat suggested a few adaptations to ARO proposals. TGA - agrees with using Brooke Street CC but wants to include some of TGF voters (Hurst Lane, Thunderbolt Way estate.) TGB - keep station at St Paul's school but take in some of Alexandra Road and Thursfield Road from PEF and TGC. TGC - agrees with proposal apart from moving some of Alexandra Road to TGB. Tividale	Cllr Crompton requested that we look to move the polling station away from Tividale FC and back to Tividale Hall Primary School. Parking at the football club is difficult and can be difficult for voters to get to as it is down a cul-de-sac. The primary school is far more central and easily accessible to all.	Explore use of Tividale Hall Primary School. We changed from the school in 2021 for the July Tividale by-election. This was to prevent the school having to close again so soon after the May elections. As there were no complaints from voters at the by-election about the football club, then it remained at the football club ever since.
Wednesbury	Cllr Hughes feedback: WNA - happy to move to the Rugby Club but concerned that voters in Westbury Road and Beebee Road won't travel to the Rugby Club. WNC - suggested alternative PP as Sons of Rest. WND - Happy with move to St Mary's Hall and Civil Defence Club but thinks voters in Manor House and Delville Road should go to Civil Defence Club. Happy with all other proposals	Explore Sons of Rest as alternative to Wednesbury Library. Look at changing boundary for WND for new PD.
