THE BOROUGH COUNCIL OF SANDWELL (GURU NANAK DEV JI NAGAR KIRTAN) (TEMPORARY CLOSURE OF VARIOUS ROADS) ORDER 2025

CLOSURE OF STREETS AND PROHIBITION OF WAITING

Notice is hereby given that on 30th October 2025 the Borough Council of Sandwell in exercise of its powers provided under Section 16A of the Road Traffic Regulation Act 1984 pursuant to Section 14B(6)(b) and of all other enabling powers intends to make the following Order:

- This Order may be cited as the Council of Sandwell (Guru Nanak Dev Ji Nagar Kirtan) (Temporary closure of various roads) Order 2025
- 2. On Sunday 2nd November 2025 from 05.00hrs, no person shall cause any vehicle, to proceed along the following lengths of roads:

Road closed 05.00hrs – 11.00hrs

George Street, West Bromwich – for its entire length

High Street, West Bromwich – from its junction with Overend Street to its junction with Bull Street / West Bromwich Ringway

Roads closed 09.00hrs - 16.00hrs (on a rolling basis)

West Bromwich Ringway, West Bromwich – from its junction with Spon Lane to its junction with Bull Street

Bull Street, West Bromwich – from its junction with West Bromwich Ringway to its junction with Reform Street

Reform Street, West Bromwich – from its junction with Bull Street to its junction with Congregation Way (including the traffic island).

Congregation Way, West Bromwich – in its entire length

Cronehills Linkway, West Bromwich - from its junction with A41 The Expressway to its junction with Bratt Street

Bratt Street, West Bromwich – from its junction with Cronehills Linkway to its junction with Lombard Street.

Lombard Street, West Bromwich- In its entire length

High Street, West Bromwich – from its junction with New Street to its junction with Dartmouth Road

Lodge Road – from its junction with High Street to its junction with Grange Road

Edward Street, West Bromwich – from its junction with Lodge Road to its junction with Victoria Street

Victoria Street, West Bromwich – In its entire length

Price Street gyratory, West Bromwich – from its junction with St Michael Street to its junction with Moor Street

Moor Street, West Bromwich – In its entire length

Bromford Lane, West Bromwich – In its entire length (including the Kelvin Way / Brandon Way / Bromford Road traffic Island)

Bromford Road, Oldbury - In its entire length

Oldbury Ringway – from its junction with Bromford Road to its junction with Freeth Street

Church Street – In its entire length

Halesowen Street – at the point of its junction with Birmingham Street (the mini-island)

Birmingham Street – In its entire length

Oldbury Ringway, Oldbury – from its junction with Halesowen Street to Birmingham Road

Manchester Street, Oldbury - In its entire length

Birmingham Road, Oldbury – from Oldbury Ringway to its junction with Popes Lane.

Popes Lane, Oldbury – from its junction with Birmingham Road to its junction with Tat Bank Road.

Tat Bank Road – from its junction with Popes Lane to its junction with Rood End Road.

Rood End Road, Oldbury – from its junction with Tat Bank Road to its junction with Cemetery Road

Cemetery Road, Oldbury - In its entire length

St Paul's Road, Smethwick – from its junction with Mallin Street to its junction with Fenton Street

Fenton Street, Smethwick – In its entire length

Roads Closed 15.00hrs - 20.00hrs

St Paul's Road – from its junction with Fenton Street to its junction with High Street (B4169)

High Street, Smethwick (B4169) – from its junction with St Paul's Road to its junction with Stony Lane.

Road Closed 06.00hrs - 20.00hrs

High Street (B4169) – from its junction with Stony Lane to its junction with High Street (A4030)

 The one-way operation of the following road will be suspended for the duration that road closure signs and barriers are in-situ on 2nd November 2025 (anticipated hours 06.00hrs – 20.00hrs).

Trinity Street.

4. The one-way operation of the following roads will be suspended for the duration that road closure signs and barriers are in-situ on 3rd November 2025 (anticipated hours 11.00hrs – 20.00hrs)

Topsham Road – From its junction with St Paul's Road to its junction with Devonshire Road

Bertram Road – From its junction with St Paul's Road to its junction with Devonshire Road

Bowden Road – From its junction with St Paul's Road to its junction with Devonshire Road

St Albans Road – From its junction with St Paul's Road to its junction with Devonshire Road

White Road – From its junction with High Street to its junction with Silverton Road

Sabell Road – From its junction with High Street to its junction with Silverton Road

Dibble Road – From its junction with High Street to its junction with Silverton Road

5. Waiting and loading of vehicles will, on 2nd November 2025, be prohibited on the roads specified in West Bromwich between 05.00hrs and 11.00hrs

High Street – from junction with Bull Street to its junction with Overend Street – both sides

George Street – in its entirety – both sides

Thomas Street – in its entirety – both sides

6. Waiting and loading of vehicles will, on 2nd November 2025, be prohibited on the roads specified in Smethwick between 06.00hrs and 20.00hrs

High Street (B4169) – from its junction with Stony Lane to its junction with High Street (A4030) – both sides

High Street (B4169) from its junction with St Paul's Road to its junction with Stony Lane – north side only

St Paul's Road – from its junction with Fenton Street to its junction with High Street (B4169) – north side only

7. Waiting and loading of vehicles will, on 2nd November 2025, be prohibited on the roads specified in Smethwick between 10.00hrs and 20.00hrs

St Paul's Road – from its junction with Fenton Street to its junction with High Street (B4169) - south side only

High Street (B4169) from its junction with St Paul's Road to its junction with Stony Lane - south side only

8. Loading of vehicles will, on 2nd November 2025, be prohibited on the current lengths of No Waiting at any time restrictions between 10.00hrs and 20.00hrs on the roads specified in Smethwick below

Topsham Road Bertram Road Bowden Road St Albans Road White Road Sabell Road Dibble Road Stony Lane Trinity Street

- 9. The provisions of this order shall not apply to any motor vehicle which is being used by:
 - The Police, Fire Brigade or Ambulance Service (emergency service vehicles) in pursuit of their duties.
 - The Local Authority or Statutory Undertaker in pursuance of their statutory duties or powers.
 - Any vehicle being used, on the direction of, or with the permission of, a traffic marshal, designated officer or other officials authorised in the control and operation of the event or in accordance with traffic management signs.
 - Any official vehicle being used in connection with the event including those used for stewarding, crowd management and traffic management purposes.
 - Any vehicles of nurses, care workers or meal delivery drivers visiting clients within a closed road.
- 10. The provisions of this order do not apply to anything done with the permission of, or at the direction of, a Constable in uniform.
