The effect of this Order is to prohibit any vehicle driving or waiting along Union Street, Wednesbury, during the prescribed hours described in Schedule 2 of this Order and hatched on plan number 40851 S/4

The effect of this Order is to prohibit any vehicle driving along Hitchens Croft as described in Schedule 3 of this Order and outlined in yellow on plan number 40852 S/4

#### Schedule 1

## Length of Union Street in the Borough of Sandwell where driving and waiting with a motor vehicle is prohibited at any time.

The section of Union Street, Wednesbury, between property numbers 38 to 62 outlined and hatched on Drawing No. 40850 S/4, annexed to this Order.

#### Schedule 2

Length and side of length of Union Street, Wednesbury in the Borough Council of Sandwell where driving and waiting is prohibited at any time except for loading and unloading vehicles between the hours of 4:00 pm and 10:00 am on Mondays to Saturdays and all day Sundays.

The section of Union Street, Wednesbury from its junction with Market Place/Upper High Street, Wednesbury for a distance of 60 metres in a westerly direction. Outlined and hatched on Drawing No. 40851 S/4, annexed to this Order.

## Schedule 3

# Prohibition of access to Hitchens Croft from its junction with Union Street, Wednesbury.

Access to Hitchens Croft from Union Street is prohibited to vehicles. Access by vehicles to Hitchens Croft to be gained via the car park entrance off The Shambles, Wednesbury. Hitchens Croft outlined and hatched on Drawing No. 40852 S/4, annexed to this Order.

The provisions of this Order shall not apply to a vehicle when being used by the police, fire brigade or ambulance service.

The provisions of this Order shall not apply to a vehicle loading or unloading.

The Sandwell Borough Council (Market Place, Wednesbury) (Prohibition of Driving) Order, 1984 - The section of one way as shown in section B on drawing number 9308 ST/4 is hereby revoked.
