- ✓ Develop secure databases or platforms to store and manage sensitive information related to potential victims, perpetrators, and support services.
- ✓ Collaborate with relevant departments to establish data sharing protocols that prioritise confidentiality, compliance with data protection regulations, and interdepartmental coordination.

#### Reporting and Case Management Systems:

- ✓ Implement reporting mechanisms and case management systems that allow for the efficient and secure reporting, tracking, and monitoring of modern slavery cases.
- ✓ Ensure that these systems provide clear workflows, automate processes, and facilitate communication and collaboration among relevant stakeholders.
- ✓ Integrate analytical tools to generate insights and identify trends that can inform preventive measures and targeted interventions.

#### Information Security and Privacy:

- ✓ Strengthen information security protocols to protect sensitive data related to modern slavery cases, victims, and investigative processes.

- ✓ Ensure compliance with relevant data protection laws and regulations to safeguard the privacy and confidentiality of individuals involved in modern slavery cases.
